The vacancies arising out of the restructuring will be filled up only from among the officials who fulfill the eligibility criteria laid down in the relevant Recruitment Rules for the post.

However, these HSG-II/ HSG-I posts will be deemed to have been upgraded to HSG-I/ HSG-I (NFG) grades only w.e.f. dates they are filled up, i.e; from the date, the promoted official assumes the charge. Otherwise, the post will remain in the lower grade.
