



MINUTES OF THE COMMITTEE FOR COMPASSIONATE ENGAGEMENT(CCE)
MEETING HELD AT O/o THE CPMG, THIRUVANANTHAPURAM ON 20-04-2022 AND
VC HELD ON 19-05-2022

The Committee on Compassionate Engagement (CCE) comprising the following members met on 20-04-2022 at Thiruvananthapuram and VC held on 19-05-2022 to consider the requests of dependents of deceased Gramin Dak Sevaks for engagement as GDS on compassionate grounds in Kerala Postal Circle.

The last meeting of the CCE was held at the office of the Chief PMG, Thiruvananthapuram on 01-10-2021. 44 cases were placed before the committee, out of which 36 cases are received matured during the intervening period and 8 cases were set aside for considering in the next CCE by the previous CCE which met on 01-10-2021. 2 requests of compassionate engagement are set aside for next CCE by the committee for want of more documents. While examining each case, the committee kept in view the guidelines contained in Directorate Letter No 17-1/2017-GDS dated 30.05.2017, Directorate letter No.17-02/2018-GDS dated 08.03.2019, 17-01/2017-GDS(Vol-I) dated 09-02-2022, GDS (Conduct and Engagement) Rules 2021 amended from time to time and subsequent clarifications on the subject issued by the Postal Directorate.



The Committee examined 42 cases listed in the Annexure-I and recommended 30 cases and did not recommend 12 cases. Secondary School Examination pass certificate of 10th standard with passing marks in Mathematics and English (having been studied as compulsory or elective subjects) conducted by any recognized Board of School Education of the Government of India/ State Governments/ Union Territories in India shall be a mandatory educational qualification for all approved categories of Gramin Dak Sevaks. The candidate should have studied the local language at least upto 10th standard [as compulsory or elective subjects] as declared by the state Government or as per constitutional provision relating to the 8th schedule of Constitution of India. The approved candidates should be engaged only after obtaining the required certificates duly verified, as per Directorate letter no. 17-39/2012-GDS dated 20.05.2016. Before issuing engagement order, the Divisional Head should ensure that the approved candidates fulfill the condition of basic computer training, which is a mandatory requirement for recruitment to GDS posts as prescribed vide Directorate letter No. 17-02/2018-GDS dated 08.03.2019. The candidates who did not possess requisite educational qualifications at the time of death of the GDS or while applying for engagement on compassionate grounds were also considered as eligible and they may be given time upto maximum 3 years for acquiring minimum required educational qualification as prescribed vide the terms and conditions mentioned in Directorate Letter No 17-01/2017-GDS(Vol-I) dated 09-02-2022. Upper age limit of the applicants can be relaxed wherever found to be necessary and the powers to relax the upper age limit of the applicant are vested with the Head of the Circle.

List of GDS cases recommended by the Committee for compassionate engagement in the meeting held on 20-04-2022 and VC on 19-05-2022 are mentioned in Annexure –II and the post, against which the compassionate engagement is recommended, is also indicated against each. These GDS posts are identified by the concerned Divisional Heads.

The following requests for compassionate engagement are not recommended by the committee for the reasons mentioned below.

1) Smt Mahija T, Sister of Late Manojkumar T, BPM, Mambram, Thalassery Dn

The case of Smt Mahija T is examined by the CCE convened. The committee observed that the applicant was a married sister and was not wholly dependent on the deceased GDS at the time of his death. The husband of the applicant is working as driver in Saudi Arabia. Therefore, the Committee for Compassionate Engagement is not recommending the case of Smt Mahija T.

2) Smt Remya K Abraham, D/o Late K M Abraham, ABPM, Arpookara, Kottayam Dn

The case of Smt Remya K Abraham is examined by the CCE convened. The following are the conclusions of the CCE. The applicant was married at the time of death of ex-GDS. The husband of the applicant is working in IHRD, Puthupally. The applicant cannot be considered as wholly dependent on the deceased GDS at the time of her death. In view of reasons above, the Committee for Compassionate Engagement is not recommending the case of Smt Remya K Abraham.


3) Smt Rejitha R M, D/o Late Valsarajan R M, ABPM, Nallarachal, Calicut Dn

The case of Smt Rejitha R M is examined by the CCE convened. The following are the conclusions of the CCE. The widow of deceased GDS has expired. The younger daughter of the deceased GDS is working as GDS MD, Manassery P O. In view of reasons above, the Committee for Compassionate Engagement is not recommending the case of Smt Rejitha R M.

4) Sri Ajeesh G V, S/o Late V R Vijayan, GDS MD, Thuravoor, Alappuzha Dn

The case of Sri Ajeesh G V is examined by the CCE convened. The following are the conclusions of the CCE. The widow of the deceased is working as a Anganwadi worker. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Sri Ajeesh G V.

5) Shri Akhil V Raj, S/o Late V P Raju, GDS MD, Mattilayam, Idukki Dn

The case of Shri Akhil V Raj is examined by the CCE convened. The following are the findings of the CCE. The widow of the deceased GDS is working as Nursing Assistant, PHC, Ayavana, Ernakulam with a monthly salary of Rs.40515/-. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Shri Akhil V Raj.

6) Smt Ujisha P, D/o Late Unni P, ABPM, Mannakavu, Vadakara Dn

The case of Smt Ujisha P is examined by the CCE convened. The following are the findings of the CCE. Initially, Smt Girija T, W/o Late Unni P applied for compassionate engagement on 09-02-2016. Since the widow was 56 yrs old and non matriculate, the applicant was directed by CO on 10-03-2017, to propose some other eligible family member, if any to apply for the post. Now, Smt Ujisha P, D/o Late Unni P has applied for the post on 12-11-2020. The widow of the deceased is presently staying with the son of the deceased GDS and son is working in a Pvt firm. The applicant was married on 26-12-2004, ie before death of ex-GDS in 2015 and was living separately at the time of his death. In view of the foregoing grounds, the Committee for Compassionate Engagement is not recommending the case of Smt Ujisha P.


7) Smt Praseeda P P, D/o Late Mohandas P P, GDS MD, Kannattipadi, Tirur Dn

The case of Smt Praseeda P P is examined by the CCE convened. The following are the findings of the CCE. The widow of the deceased GDS is working as Anganwadi Teacher. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Smt Praseeda P P.

8) Sri Manu A, S/o Late T Suresh, BPM, Kattayad, Thalassery Dn

The case of Sri Manu A is examined by the CCE convened. The following are the findings of the CCE. The wife of the applicant is working as LP School Assistant in AUP School, Vellamunda. The married daughter of ex-GDS is also working as ABPM, Kottarakunnu BO. In view of the forgoing grounds, the Committee for Compassionate Engagement is not recommending the case of Sri Manu A.

9) Shri Sooraj Sadan, S/o Late C Sadanandan, ABPM, Areekkara P O, Mavelikkara Dn

The case of Shri Sooraj Sadan is examined by the CCE convened. The following are the findings of the CCE. The widow of the deceased GDS is a state pensioner. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Shri Sooraj Sadan.

10) Kum Rakhi S, D/o Late Raghavan G, GDS, Mannadi, Pathanamthitta Dn


The case of Kum Rakhi S is examined by the CCE convened. The following are the findings of the CCE. The applicant is an unmarried daughter and the widow is unemployed. But the son of the deceased GDS is working in CRPF. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Kum Rakhi S.


11) Smt Sreelatha M, D/o Late M Kora, ABPM, Nettanige PO, Kasargod Dn

The case of Smt Sreelatha M is examined by the CCE convened. The following are the findings of the CCE. The son of the deceased GDS is a state govt employee. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Smt Sreelatha M.

12) Shri Abhilash A B, S/o Late Balakrishnan V, BPM, Echchome, Thalassery Dn

The case of Shri Abhilash A B is examined by the CCE convened. The following are the findings of the CCE. The widow of the deceased GDS is a state pensioner. Since there is an earning member in the family, the Committee for Compassionate Engagement is not recommending the case of Shri Abhilash A B.
