This is in continuation of this office letter of even number dated 06.12.2022 wherein the list of selected candidates in the Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postal Assistant/ Sorting Assistant from Postman/ Mail Guard and MTS conducted on 07.08.2022 and Data Entry Skill Test (DEST/Paper-III) conducted on 25.09.2022 was announced.

2. Now the competent authority is pleased to announce the Division-wise allotment of selected candidates as per relevant Recruitment Rules & instructions on the subject and as per the merit list and order of preference which is enclosed as Annexure-I.

Allotment list is prepared according to the seniority in merit prescribed by Directorate vide letter No.04-08/2019-SPN-I dated 11.12.2020. Inclusion of candidate in Circle/Division gradation list may be made as per the order of the allotment list.

3. Details of departmental vacancies for the year 2022 is enclosed as Annexure-II.

13 (Thirteen) UR Vacancies earmarked for PwBD horizontal reservation have been kept aside awaiting clarification from Directorate on DoP&T OM No.36012/1/2020-Estt.(Res.-II) dated 17.05.2022 communicated vide Directorate letter No.SC-12/9/2022-SCT-DoP dated 14.09.2022.

Due to non-availability of qualified ST candidates, 42 (Forty two) ST vacancies are remaining unfilled. Division-wise details of the unfilled ST vacancies is enclosed as Annexure-III.


4. The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the head of the unit concerned. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. In case any vigilance/ Disciplinary case is pending against any of the officials, posting orders should not be issued without obtaining specific orders from this office and instructions contained in Directorate's letter no: X-7/6/2022-SPN-II dated 12.04.2022 and 10.11.2022 may be adhered to.

5. The Divisional Head should ensure issuance of offer of appointment letter to the successful candidates immediately. Further, the Divisional Heads will send the joining status of the candidates before 28.12.2022 to this office. Divisional Heads are requested that particulars of successful candidates, viz. Roll numbers, names, community and their eligibility to appear in the said examination are re-checked before issuing offer of appointment. If any discrepancy is found the same may be corrected and the matter be reported to this office immediately. They will also check that number of such candidates allotted to their unit is not more than the number of vacancies proposed to be filled through the said examination.

6. In respect of SC/ST candidates, "promotion of the candidates is provisional subject to verification of their caste status. Divisional Head will take an undertaking from the officials to this effect at the time of their relief and ensure verification of caste status within one month".


7. This result is subject to the outcome of various cases pending before the Hon'ble Court/CAT.


