The Competent Authority is pleased to announce the result of LDCE/Competitive Examination held on 04.09.2022 for Promotion/Recruitment to the cadre of Postman and Mail Guard from eligible MTS and GDS for the vacancy year 2022 with respect to the Idukki Division. Since there are no qualified MTS candidates in the LDCE for promotion to postman the unfilled promotion quota vacancies are added to the already notified GDS examination quota vacancies.


